9837 It was **RESOLVED** that the Minutes of the meeting held on 2 September 2015 were agreed and signed by the Chairman as a true record.

Decisions Made by Swanley Town Council

Application SE/15/02624: Variation of condition 2 of 08/01850/CONVAR (Appeal reference APP/G2245/A/08/2092052/NFW) in order to allow deliveries to be made to the ASDA store between 05:00 and 23:00 hours on Mondays to Saturdays and between 06:00 and 23:00 on Sundays and Christmas Day, Asda Stores Ltd., London Road, Swanley.

Following discussion on this matter Cllr Morris proposed and Cllr Ball seconded that the Town Council should object to this application on the same grounds lodged in respect of the previous application.

The District Council should also be informed that the stacking of vehicles using the public highway raises serious concerns of highway safety and that situation was being made worse by the size of the delivery lorries being used. In addition the WHO guidelines were already being exceeded and therefore any increase in opening hours would only make that situation worse.

9838 It was **RESOLVED** that

- (a) Sevenoaks District Council be advised that Swanley Town Council strongly objects to this application as the proposed extension of delivery hours would be harmful to the residential amenities of properties in the vicinity due to the noise and pollution from exhaust emissions generated by the delivery vehicles which was contrary to planning policy EN1 of the Local Plan. The planning conditions were set when the store was opened and there has been no material change in the surrounding neighbourhood during that time that would make changes to delivery times viable.
- (b) The Town Council requests that Asda seeks to find a solution to the issue of vehicles queuing to enter the delivery yard and considers it should find a suitable parking waiting area and better manage its supply chain. The stacking of vehicles using the public highway raises serious concerns of highway safety and that situation was made worse by the size of the delivery lorries being used.
- (c) The WHO guidelines are already being exceeded and therefore any increase in opening hours would only make that situation worse.
- (d) The District Council be further advised that the Town Council was also concerned that the existing delivery conditions are being flouted and requests the District Council to take enforcement action against this.
- (e) The Town Council further requests that this matter is considered by the District Councils Development Control Committee and not considered on delegated powers.

 - (b) The Town Council also strongly objects on highway grounds. The development would restrict vehicular sight lines and affect parking. Also the planning application made no on-site provision for a turning area and therefore that would considerably increase the highway objections which the Town Council has already stated.
