The development would require the loss of two Oak trees which are covered by TPO's this would be contrary to policies SP1 and EN1 While the latest plans show a reduction of two properties against the previous application (19/01766) this would still be a cramped development. Consideration should be given to their mass and design which would be detrimental to the street scene. NPPF 124c The area is already congested with vehicles and the proposals fail to meet Kent guidelines for parking.

While this site has been left in a state of dereliction, it is still a public open space which, if developed, would be a further erosion of green space in Swanley.
