3. Minutes of Meeting held on 7th December 2021 and Matters Arising

AGREED as a true record.

4. SDC and consultation comments on NP

LH reported that she had been pleasantly surprised by the SDC comments which were mainly favourable or suggested strengthening the policies.

The group went through all the policies and proposals for SNP action and agreed proposals for further work proposed and in particular:

SwC1 it was agreed the policy would stand but that RH's update in relation to acquisition and borrowing to complete the health centre scheme on the cark park would be included. SH reported that there would be limited pubic car parking on the site, but that those available would be on a first come first served basis and free only for visitors of the Centre for appointments. It would not be possible to accommodate consultation which requested free parking for all visitors to the facility.

SwC2 – agreed to add to narrative as suggested in the report and move amenity space element of the policy to housing section and cross reference

SwC5 – agreed to amend as suggested

SwHC1 – LH to chase re SDC comments on design guidelines from SDC

SwHc2 –agreed to update re owners and LH to chase Conservation officer re local listing in order to confirm final wording

SwHC3 – agreed to re-word

SwEE1 – agreed to strengthen as suggested. RB offered to produce maps based on LH advice.

SwEE2 – agreed to re-word and create map and new policy related to Swanley Village employment site. GD suggested that Upper Hockenden farm to be added to main employment sites.

SwEE4 - agreed to re-word to be broadened to include the whole of the NP area.

SwH1 – agreed heritage and character assessment needed to help re-word this policy and **SwH6**, rather than wait for SDC study.

- Regulation 16 consultation to be run by SDC (risk of delay as SDC cannot be forced to do this quickly) – 6 weeks
- Independent examination
