5. Regulation 14 Consultation planning (2 documents attached)

The focus of the consultation was agreed to be on the NP itself and the Swanley Village Design Guide which is part of it. The consultation would run from Monday 9th January to Friday 17th February 2023.

LH had circulated the excerpt of the NP regulations which set out which consultation bodies would need to be consulted. It was **agreed** that LH would produce a letter to go to SDC from STC asking for their direct contacts and notifying them of the Reg 14 consultation proposals. It was **agreed** that parishes at Crockenhill and Hextable and Bromley Council would be included.

LH had circulated a draft comments form for the consultation with blanks for STC to add details of where hard copies of NP documents being consulted upon would be made available along with comment forms. Currently this would be Swanley Link. The form would also be made available on line.

The group **agreed** the content of the form but asked that it be amended to make clear that agents and landowners should be from Swanley only.
